ORDER

In the meeting held on the 22nd December, 2011 chaired by the Chief Secretary, Meghalaya the following decisions have been taken for strict compliance by the district Superintendents of Police of East Khasi Hills, West Khasi Hills, Jaintia Hills and Ri Bhoi Districts with effect from the 27th Dec, 2011.

1. All loaded coal and cement trucks will be allowed to ply downhill to Ri Bhoi District/ Guwahati from Jaintia Hills and West Khasi Hills through the city of Shillong only between 8PM to 8AM.
2. Empty cement and coal trucks coming up from Ri Bhoi District and proceeding to West Khasi Hills and Jaintia Hills Districts will be allowed to pass through Shillong between 8AM to 8PM.
3. Superintendent of Police, East Khasi Hills District will ensure the implementation of this rule.
4. The Superintendents of Police, West Khasi Hills, Jaintia Hills and Ri Bhoi Districts will work out their timing so that the vehicles pass through Shillong only during the time as provided above.
5. Violators will be fined to the maximum as per the law.
6. Respective District Superintendent of Police will give adequate publicity of this traffic arrangement in his/her jurisdiction.

Inspector General of Police (L/O) I/C Eastern Range will coordinate and ensure smooth implementation of the above arrangement.


